4. There will be new Monkfish Scheme in place for 2013 starting April 1st. Monkfish Scheme Vessels will be issued vessel specific catch limits by DAFF.

6. There is no specific national quota for Cod in Vla. Vessels may only have 1.5% Cod retained on board at any time - similar to catch composition requirements that exist.

7. Catch composition rules for Haddock in area VI are no longer in force. Members are advised that whiting have not yet been removed from the catch composition rules. IFPO will advise with any changes in due course.

8..It is mandatory that all vessels must use SMP from October 2012 in Celtic Sea.

9. Vessels in the Monkfish Scheme restricted to 2.5MT

10. Vessels in Monkfish scheme restricted to 6 MT

11. Vessels in Monkfish Scheme restricted to 10MT

12.Vessels in Monkfish Scheme restricted to16 MT Whiting in VIIb-k
